CRIMINAL RECORDS CHECK AUTHORIZATION Baltimore Yearly Meeting of Friends

I hereby give my permission for the Baltimore Yearly Meeting to obtain information relevant to youth work relating to my criminal history record. The criminal history record, as received from the reporting agencies, may include arrest and conviction data as well as plea bargains and deferred adjudications. I understand that this information will be used, in part, to determine my eligibility for employment, or a FAP/volunteer position with Baltimore Yearly Meeting youth programs. I also understand that as long as I remain an employee, FAP, or volunteer here, the criminal history records check may be repeated at any time. I understand that I will have the opportunity to review my criminal history and a procedure is available for clarification if I dispute or wish to explain the record as received. I also understand that, by law, I may review a copy of the transcript, but will not receive a copy of the document in any fashion or form.

This application and the resulting report(s) will be maintained in a lockable file cabinet with access granted only to those defined by policy. Current policy provides access to the Youth Secretary, General Secretary, and (in lieu of one of the aforementioned staff members) the Administrative Secretary. If an individual will be present at or working with our camps, access will also be given to the Camp Secretary. In addition to these staff members, the Clerk(s) of Youth Programs Committee (YPC) and the FAP Sub-Committee Clerk(s) may have access to the information. Camping Program Committee (CPC) Clerk(s) will also be granted access if the applicant will be involved with our camps. If an issue arises that creates concern for staff and/or committee, access may also be granted to the following: Yearly Meeting Clerk, Interim Meeting Clerk, Clerk of BYM's Trustees, and any Monthly Meeting Clerk of a Meeting attended by the applicant. BYM will use the information obtained from these checks to determine a person's eligibility to work with Yearly Meeting youth in any capacity, including at the Monthly Meeting level. This background check does not necessarily fulfill any Monthly Meeting requirement.

I, the undersigned, do for myself, my heirs, executors and administrators, hereby remise, release and forever discharge and agree to indemnify the Baltimore Yearly Meeting and each of their officers, directors, employees, and agents harmless from and against any and all causes of actions, suits, liabilities, costs, debts, and sums of money, claims, demands, whatsoever, and any and all related attorney's fees, court costs, and other expenses resulting from the investigation of my background in connection with my application to become an employee, FAP or volunteer of Baltimore Yearly Meeting.

I have never been convicted of a sexual offense or sexual offenses against children. To the best of my knowledge, no one has ever accused me of being sexually, physically, or emotionally abusive of a child.
